REQUIREMENTS

You need a Player Licence to take part in all ETTA championships, tournaments and competitions. The only exceptions by rule are:

- Local League competitions, County Championships, National knockout competitions, ETTA approved and 1 star open tournaments.
- If you do not have a licence you can take part in licence events by paying a single tournament fee along with your entry fees.
- If you intend to enter only one or two events during the year, the single tournament fee could be the best option for you. However you will not be eligible for any other benefits or services available through the Player Licence scheme.

NON-ENGLISH PLAYERS

All players who are members of other national associations must have a current licence or pay the single tournament fee unless they provide the ETTA with proof of nomination for that competition from their home association. Such proof must be in writing and must be received by the ETTA General Secretary at the association's head office prior to the start of the competition.
